UTILISATION OF PROCEEDS FROM THE TAIWAN DEPOSITORY RECEIPTS ISSUE

Further to the announcement of the Company on 29 October 2010, 3 November 2010, 1 December 2010, 29 December 2010 and 1 July 2011, the Board of Directors of BH GLOBAL MARINE LIMITED (the "Company") wishes to provide an update on the use of the proceeds raised from the Company's Taiwan Depository Receipts ("TDRs") issue.
